All lengths of vessels are in Metres Length-Overall (LOA).

All Berthing Charges are for non-exclusive berths unless otherwise stated.

Berthing is as directed by Harbour Master and the Harbour Master's decision is final.

Berthing is subject to Berthing Terms and Conditions

Where seasonal berths are applied, summer shall be **1 April to 30 September** and winter shall be **1 October to 31 March**.

Under The Merchant Shipping and Fishing Vessels (Port Waste Reception Facilities) Regulations 2003 (as amended),

All waste disposal is subject to charges outlined in Table 10.

Monthly charges are per calendar monthly.

## 1. CHARGES FOR FISHING VESSELS

### Rates and Charges from 1 April 2024

By agreement with Eyemouth Harbour Trust, locally owned, registered fishing vessels regularly engaged in fishing from and landing in Eyemouth Harbour, on prior application being made in writing to the Harbour Master, may be eligible for compounded arrangements as follows:

**\*Part seasons of 3 months or more may be applied for whereby 1/6<sup>th</sup> of the seasonal rate + 30% will apply. For less than 3 months, see Table 4 below.**

If a boat changes ownership, part way through a season, there is no automatic right to transfer the berth to the new owner. Any change in ownership or vessel will require a new berthing application to be submitted.

Notes applicable to local composite rates:

1. Annual dues cover the year 1 April to 31 March and cannot be charged pro-rata.
2. Eligibility for composite rates is assessed annually based on previous year's landings.
3. Where no track record exists at Eyemouth, Category D rates will apply.
4. Owners/Skippers who fail to pay compounded charge within agreed terms and those not eligible for composite rates will be liable for appropriate charge in Table 2A.

5. The compounded charge herein shall cease to be applicable to any vessel in this class continuously occupying a berth at the Trust's quays or who has not made a significant landing for a period in excess of 30 days. Such vessels will then be classed as either visiting or laid up and will be liable to be charged appropriate rate in Table 2A, 2C or 2D below.
6. Marine Scotland declaration must be completed. If this condition is not met, a higher rate of 3.5% landings is applicable.

**TABLE 2D**

**FISHING (LOCAL & VISITING) LAID UP DUES (SUBJECT TO VAT)**

In certain circumstances, any vessel benefiting from composite rates under Table 2B who has not made a significant landing or a period in excess of 30 days will be liable to be charged as follows. Any vessel in this category for a period exceeding 3 months will be subject to review and may result in daily rates in Table 2A or Table 7 being applied.

**NOTES APPLICABLE TO ALL FISHING VESSELS whether local or visiting.**

1. Berthing is subject to suitable arrangements being agreed in advance for collection of landing dues.
2. Marine Scotland declaration must be completed. If this condition is not met, a higher rate of 3.5% landings is applicable.
3. In cases where skippers sell directly to Merchants, liability to account for Landing Dues rests jointly and severally with the Skipper / Owner if the Merchant fails to account to the Trust for the Landing Dues.
4. Commercial fishing vessels are those who are licenced as a fishing vessel.
5. All vessels must produce satisfactory evidence of Third-Party Liability insurance upon request. Sight of Certificate of Registration may also be required.

COMMERCIAL CREEL VESSELS WILL PAY ANNUAL HARBOUR DUES AS FISHING VESSELS ABOVE.

ANY NON-COMMERCIAL VESSELS WILL BE CHARGED AS LEISURE RATES DETAILED IN TABLES 3 & 4 BELOW.

Any item or service not covered specifically by this Schedule of Rates and Charges will be assessed by Eyemouth Harbour Trust, who shall set an appropriate fee for that item or service.

It should be further noted that any legitimate expense incurred by the harbour authority directly associated with any vessel, skipper, owner, or agent, whether requested or not by that person or vessel shall be recharged to that person/vessel at cost plus any administrative or service costs associated with the expense.

**Notes applicable to storage of goods.**

1. All goods and ships equipment, including trawl doors, nets, ropes, drums, lobster / crab, prawn pots and fish boxes to be stored on the quay only with the permission of, and directed by the Harbour Master.
2. All goods must be clearly marked with vessel's name and/or registration number.
3. Goods stored without permission will be charged a penalty.
4. Goods stored without authorisation will be disposed of after 14 days.
5. The Trust will not be responsible for the safe custody of any goods landed, deposited, or stored upon any of their quays, wharfs, or premises; nor will they accept any liability for any loss (whether partial or total) or damage, however arising, which may happen to such goods.
6. As the Trust have no charge or custody of goods landed, deposited, or stored on quays, wharfs, or premises, the Trust strongly advises Owners or Consignees of such goods to arrange insurance cover to have them watched whilst the goods remain there.

## **FUELS AND PETROLEUM PRODUCTS**

Vessels who do not have an account with Chrystal Petroleum, who require fuel from the tank should contact the Harbour Master.

Fuel agents are permitted to sell fuel across the quayside, however, in these circumstances, the following regulations will apply.

1. Any company, agency, or individual wishing to use Eyemouth Harbour Trust quays for the transfer of petroleum products to and from vessels must first apply and obtain written permission from the Trust. Any company, agency or individual not obtaining written permission will not be allowed to undertake any transfer of petroleum products.
2. All approved agencies supplying fuel and other oils must account monthly to Eyemouth Harbour Trust for the total amount of oils, which have been exported or sold across the quay.
3. Failure to comply with the above will result in the consent being withdrawn.
