INSURANCE COVER:

Vessel owners shall maintain third party insurance in respect of their vessel, crew, and guests to cover all risks including damage by fire or other hazards to other craft and persons using the Harbour Area, and to the property of Eyemouth Harbour Trust as follows:

£3,000,000 for commercial vessels under 8m LOA, and all leisure craft

£5,000,000 for commercial vessels 8m LOA and above, or such greater sum as may be required by Eyemouth Harbour Trust and intimated to the Owner. Insurance must not exclude wreck removal. Such insurances shall be maintained with a reputable insurance company and evidence that the Vessel is so insured shall be provided to Eyemouth Harbour Trust with this application. Vessels found to be without such insurances may have any allocated berth cancelled immediately.

I hereby confirm that the aforementioned vessel has comprehensive insurance cover with third party liability in place for the period for which berthing is applied for. The Certificate of Insurance is enclosed.

I hereby confirm that by signing this application I accept the EHT berthing *terms & conditions* and *mooring guidance*.
