

# MARINE RECREATIONAL & LEISURE ACTIVITY POLICY STATEMENT

The Eyemouth Harbour Trust, as a Statutory Harbour Authority, acts as a regulator and enforcer regarding a range of legal duties and powers conferred within Acts of Parliament and within full compliance of the Port Marine Safety Code for safely managing marine operations within statutory harbour limits.

The scope of the Marine Recreation & Leisure Activity Policy is to formally recognise the growth and diverse range of leisure activities undertaken within Eyemouth Harbour's statutory harbour limits.

This policy will regulate the safe and efficient use of the harbour and all who navigate and operate upon its waters and will provide direction, guidance and support to those organisations, associations and individuals who may promote or undertake marine based leisure activities within the statutory harbour limits.

To comply with marine safety regulatory standards and legislation all marine leisure activity will comply with the following safety directions as required:

- All marine leisure activity will be considered/assessed on a risk mitigation basis in compliance with the Port Marine Safety Code. All clubs, associations and event planners will be required to submit a formal risk assessment of proposed marine leisure activity to Eyemouth Harbour Trust for approval.
- All marine leisure activity will comply with national legislation & regulatory standards, the Eyemouth Harbour General Bylaws and will be subject to the Eyemouth Harbour Trust Marine Enforcement Policy as necessary.
- All marine leisure craft operators will comply with any General Direction made by the Eyemouth Harbour Trust and any Special Direction made by the Eyemouth Harbour Master or their delegated marine assistants.
- Jet skis, paddle boards, inflated leisure equipment or any other similar floating or towed leisure equipment will be prohibited for use within the operational harbour, navigable channel and immediate port entrance which may obstruct, interfere with or cause nuisance with other harbour users.
- No leisure craft or leisure activity shall obstruct or interfere with the safe navigation of commercial vessel operations on any occasion whilst underway or alongside whilst within the statutory harbour limits or obstruct/interfere with any commercial activity or commercial development taking place.

- It is a requirement before any marine leisure activity can proceed to request approval to proceed from the Harbour Master's office and notify again upon completion of such marine leisure activity.
- Eyemouth Harbour Trust is committed to engaging in full stakeholder consultation when formulating operating policy, safety guidance and safe operating procedures.
- The Harbour Authority will promote best practice safety advice and information to Harbour Users and stakeholders through multiple platforms such as mooring and other guidance documents, website information, newsletters, and stakeholder safety awareness sessions in conjunction with the Eyemouth Harbour Users' Group.
- It is expected that all owners and operators of MCA Coded craft shall comply with the manning and operational requirements of the relevant code pertaining to their commercial operation as laid out in the Eyemouth Harbour Berthing Terms and Conditions.

The above guidance is not exhaustive and operates in conjunction alongside the extant Eyemouth Harbour Marine Safety Policy, the Marine Enforcement Policy, and the Port Marine Safety Code guide to good practice.
